LSSE-designed Collier Community Park and Dek Hockey Rink Opens



LSSE is providing engineering and permitting services to the Township of Collier for the phased development of the \$8.5 million Collier Community Park. The park is located on approximately 70 acres that previously housed U.S. Department of Defense facilities. Collier obtained the property, developed a Park Master Plan, and began work in the Spring of 2012 with demolition of ten structures at the former Army Support Facility to facilitate construction of Phase 1.

Phase 1 construction included basketball, tennis and pickleball courts, multipurpose fields, a lighted Dek Hockey rink, restroom facility, relocated playground and a picnic pavilion. The Phase 1 Ribbon Cutting for the Dek Hockey rink was December 6, 2012. Renovation of an existing 25,000 square foot building to function as a community center and construction of a 10,670-square foot gymnasium addition is scheduled for completion in May 2014.

LSSE services include:

- Surveying, DEP Permitting, design and preparation of construction plans and specifications for landscaping, infrastructure (electric, gas, sanitary and water service), trails (Connection to the Panhandle Trail), pavilions, parking areas, parking lot lighting, stormwater facilities, courts, multipurpose field and restroom buildings.
- Preparation of separate bidding documents for utilities and infrastructure, grading, paving,

LSSE Presents Recent MS4 Updates to Conservation Districts

LSSE recently had the opportunity to present at two area conservation district seminars regarding the Municipal Separate Storm Sewer System (MS4) permit program. Presentation topics included the origin of the MS4 program in the Federal Clean Water Act, discussion of the need for an MS4 permit, MS4 program goals and recent program changes.

The presentation also included MS4 permit deadlines, filing fees, outfall mapping and testing requirements, illicit discharge detection and elimination and Total Maximum Daily Load (TMDL) plans. Current regulations stipulate that municipalities must provide a written TMDL plan for any regulated, small MS4 that discharges to a surface water with a TMDL plan approved by the Environmental Protection Agency or Pennsylvania Department of Environmental Protection.

LSSE presented these updates to the Beaver County Conservation District on November 8, 2012 and the Allegheny County Conservation District on December 12, 2012. LSSE's Matthew T. Carroll, CPESC and Timothy R. McClelland, P.E. led the presentations with participation by Robert Scheib, P.E. and James A. Kuncelman, P.E. of the Pennsylvania Department of Environmental Protection.
