### BIPARTISAN INFRASTRUCTURE LAW

On November 15, 2021, the Infrastructure Investment and Job Act, also known as the "Bipartisan Infrastructure Law" was signed into law. This law provides \$550 billion in infrastructure funding over fiscal years 2022 through 2026. This includes: funding for elimination of lead pipes in water distribution systems, high-speed Internet access, roadway and bridge improvements, investments in public transit, transportation upgrades including airports and ports among other infrastructure.

Information available at this writing suggests funding will be funneled through the traditional funding agencies such as PennVEST, USDA RUS, the Department of Transportation and others. Funding is expected to be disbursed for use in mid to late 2022. Stay tuned for more information from LSSE's Funding Leadership Team as it becomes available. In the meantime, if you have a project, please feel free to discuss with your LSSE client manager to move it to "shovel ready" status to improve your community's chances of taking advantage of these funding opportunities.

## MUNICIPAL PHASE II CONSENT ORDER AND AGREEMENT

LSSE was appointed prime consultant for the 3 Rivers Wet Weather (3RWW) Program Management (PM) Team in 2021.

As part of PM Team appointment, LSSE and 3RWW are tasked with representing the interests of the 83 municipalities tributary to the Allegheny County Sanitary Authority (ALCOSAN) system as it relates to the one of the most complicated wet weather sewage facilities plans in the United States including assistance with the municipal Phase II Consent Order and Agreements (COAs) with the Allegheny County Health Department (ACHD) and / or Pennsylvania Department of Environmental Protection (PaDEP).

3RWW has been actively supporting municipal compliance via the development of tools, templates, and recommendations to the region at-large. LSSE has a strong presence at three hybrid monthly meetings including the Wet Weather Working Group (3WG), the Separate Sewer Subcomittee (SSS) and the Combined Sewer Subcomittee (CSS), often times presenting and facilitating multi-municipal and regional stakeholder dialogue pertaining to key wet-weather topics impacting the region.

Applications can be developed and customized to meet each project requirement or system mapping goals. One of the most utilized capabilities is pairing the ArcGIS Online mapping with mobile applications such as ArcGIS Collector and ArcGIS Field Maps. Within those applications, there is built-in-functionality to tether to GPS equipment to collect or correct location data for assets.

ArcGIS is also the host to data that is available to TRAISR clients. Enhancement to integration with ArcGIS Online applications is in development. Combining the ease of the mobile experience with the power of TRAISR would provide a user friendly interface when entering work orders, permits, inspections. The information collected will feed back between TRAISR and ArcGIS Online to create a seamless workflow.

### CTWA PERMANENT PLANT TRANSITION

Construction of the Center Township Water Authority's (CTWA) new Water Filtration Plant started in October 2021. Foundation construction is proceeding as illustrated in the photo below.

This nearly \$70 million potable water supply and treatment project is expected to be completed in the fall of 2024. Once complete, this project ends a 13-year planning, design and construction effort by the CTWA and LSSE. This complex public works project was delivered in phases to maintain uninterrupted service to CTWA's customer base of 18,000 people and to coordinate work with the Shell Plant. This project is being completed at no cost to the CTWA customers.

Phase I included the construction and start-up of an Interim River Intake and Interim Water Treatment Plant in just 20 months. The project was delivered using fifteen separate concurrent material and construction contracts to meet schedule demands. Phase I was completed in September 2016. The capacity of the interim facility is 3 million gallons per day (MGD). Phase II included a new 5 MGD River Intake and a Residuals Processing Facility. The River Intake is a multistory facility that collects raw water from the Ohio River using tunnels and screens constructed below the Ohio River. Once collected; raw water is lifted to the treatment plant by high pressure vertical turbine pumps. The new Residuals Processing Facility is located adjacent to the Interim Water Treatment Plant. Filter backwash water generated during water plant operation is treated in this facility prior to discharge to the Ohio River.

Phase III includes construction of the new Water Filtration Plant. This Water Filtration Plant will have the capacity to produce 5 million gallons of water per day. It features many advancements in drinking water treatment including enclosed supervisory control and data acquisition (SCADA), lamella plate clarifier's,
